## Description of the Change:

The Environmental Studies Department requests to change the General Education requirements for the Environmental Education and Interpretation Major to conform to the new SUNY General Education categories (see table 1). These changes will include: (1) the addition of a Diversity, Equity, Inclusion, and Social Justice (DEISJ) requirement, which will be selected from a list of classes fulfilling this category, and (2) changing the requirement for students to pick one class from four categories (Western Civilization, Other World Civilizations, The Arts, and Foreign Language) to students picking one class from three categories (World History and Global Awareness, The Arts, and World Language). The remaining General Education requirements (i.e., Mathematics, Natural Sciences, Social Sciences, DEISJ, Humanities, and Communication) are already integrated into the curriculum. These changes will align our degree program with the updated campus-wide General Education learning outcomes, though will not impact degree program learning outcomes.
