Hotel Syracuse Restoration: Panel Discussion

ABSTRACT

The panelists, all key participants in the restoration and renovation of the 90 year old Hotel Syracuse, which resulted in reopening of the property as the Marriott Syracuse Downtown, will discuss the programming, delivery process and design challenges, along with lessons learned in completing this 70 million dollar project from July 2014 to completion and the opening in August 2016. Discussion topics will include:

- Documentation for existing systems and construction for reuse/renovation.
- Restoration of existing construction and finishes, interior and exterior.
- Design and installation of new MEP and Life Safety Systems.
- Select demolition and remediation process.
- Building code challenges and solutions.
- Compliance with Interior Department Standards for Rehabilitation Tax Credits.
- Project funding and organizational structure.
- Community support and involvement.

In completing this renovation, the design team, contractors and ownership were challenged to design and construct all new mechanical, electrical, plumbing, fire protection and Life Safety Systems meeting current building codes and Marriott standards, within a building originally constructed in 1924, while restoring the significant interior public spaces to rehabilitation tax credit standards. The renovation also provided new guestrooms, along with restored historic guestroom suites. Additionally, the exterior of the building was repaired and restored. In order to complete a project of this complexity with associated costs, several grants, in addition to a tax credit investor, and construction financing were required, making the project a complex transaction requiring close cooperation of state and local governments, private investors and private banking entities. The resulting project saved a nationally recognized historic structure, in addition to prominent local landmark, returning it to productive use with modern MEP and Life Safety Systems.

He also was Architect of record and co-developer of several historic restoration projects in Armory Square area of downtown Syracuse, securing the historic rehabilitation tax credits for Bentley-Settle, Piper-Phillips, the McArthur, Worth & Cooney buildings. In 2014, Mr. Riley formed Hotel Syracuse Restoration LLC. The focus was the restoration and renovation of the 92 year old Hotel Syracuse, which opened in August of 2016 as the Marriott Syracuse Downtown. Mr. Riley attended architectural school at Onondaga Community College and Syracuse University, is a licensed Architect in New York State, and actively maintains his registration.
