Daring to Dream update

Dear College Community:

I want to provide you with an update on our *Daring to Dream* process and to express my appreciation for the way you have engaged and contributed actively to this critical process.

Recall that we began this effort formally on April 12, 2001 with a College-wide convocation in Marshall Hall. We reviewed ESF's proud history, our current teaching, research, and service efforts, and we rekindled a sense of our College's very promising future. Perhaps the most memorable part of that initial program was the opportunity our College community had to generate and share your dreams for ESF's future. I recall well the enthusiasm you generated and your commitment to ESF's students, to each other, and to our stakeholders. With Spring upon us, this may be an appropriate time to revisit our initial dreams which are recorded on the *Daring to Dream* website http://eww.esf.edu/dtd/esfdreams.htm. Please be sure that your current planning appropriately reflects those initial dreams.

As of today, I have reviewed approximately 40 *Taking Stock* Reports from academic chairs and administrative unit directors. *Taking Stock* (the second phase of our process) was an important self-assessment exercise. It served to establish our ability to understand the larger context in which we work and to know better the people we serve. Creating the capacity to plan strategically is important for our College as well as for our individual units. Based on our review of the *Taking Stock* unit reports, within the next two weeks, I will provide feedback to unit heads. Our review suggests that most units have developed good ideas and have embraced the concept of collaboration.

The development of College-wide strategic goals is an important result of our process. I have presented these goals at a Faculty Governance meeting and at other College-wide meetings. The Board of Trustees also engaged in a facilitated review of the goals at the February meeting and provided very helpful and important insights. College and individual unit goals will serve as the point of departure for further planning. The next phase of *Daring to Dream* will entail developing execution plans for our goals. To this end, we will have further discussion with the Board of Trustees at our May 10 meeting, and we will hold a Strategic Planning Council workshop on June 11th. I encourage individual units to continue to exchange ideas and information, reflect on your mission and your collaborative efforts, and to begin considering execution plans for your goals.

Daring to Dream has already produced good results, but it holds much more potential. Good luck in your efforts. Please continue to contact me with any questions or suggestions that you may have.
