Prior to the start of the meeting, Chair Fisher took a moment of silence in honor of Troy Eames, who passed away on February 7th.

Call to Order, Roll Call and Welcome

1. Consent Agenda – Chair Fisher

Chair Fisher called the meeting of the ESF Board of Trustees to order at 9:06 am. Secretary Squier did roll call. With seven voting Board members in attendance, a quorum was confirmed.

Chair Fisher brought forward an item of new business, which is a proposed resolution.

- Upon recommendation of the faculty, President and Provost, the Board of Trustees recommends that at the May 2022 Commencement, the degree of Bachelor of Science in Environmental Studies be conferred posthumously upon Troy I. Eames.
 - Trustee Fedrizzi moved to adopt the motion. Seconded by Trustee McFoy. Chair Fisher asked for a roll call vote. The motion was passed unanimously, 7-0.

RESOLVED the motion to confer a Bachelor of Science in Environmental Studies to Troy I. Eames posthumously at the May 7, 2022 Commencement is approved as presented.



Chair Fisher called for a motion to approve the consent agenda. Trustee Bartow so moved. Trustee Fitts seconded. Chair Fisher asked for a roll call vote. The motion passed unanimously, 7-0.

RESOLVED that the items in the consent agenda be approved as presented.

2. Chair's Report – Chair Fisher

- Shelby Zangari requested that the College Administration release a statement supporting GSEU's lobbying efforts to secure a budget measure to end graduate employee fees.
- Shelby also requested that the Board of Trustees release a statement by the end of February to support GSEU's lobbying timeline.
- Graham Perner, an ESF Graduate Student, suggested that the BOT work with GSEA to lobby with the NYS legislature. Chair Fisher spoke with Graham and described the regulations governing lobbying with NYS legislature and our bylaws would not give the Board power to lobby.
- Chair Fisher reminded Graham that President Mahoney has taken over leading the lobbying efforts in Albany.
- Chair Fisher said it would not be wise to include a presentation suggesting that we get involved in lobbying in cooperation with the GSEU. Both the college and the GSEU have every right to lobby the NYS legislature and Chair Fisher believes that their success is important for the institution.

Trustee Fedrizzi made edits to the resolution to add language as follows to the duties and charges statement (amendments in all caps):

- "Facilities
 - Review and make recommendations regarding college facilities, systems and infrastructure, including opportunities for incorporating green, HEATHLY and sustainable technologies, STRATEGIES and materials."

Trustee Marko made a recommendation to add Item D to make a mention that Article VI, Section 2 (electronic submission) is amended.

 Note: This amendment to Article VI, Section 2 was adopted at the May 14, 2021 Board meeting via board resolution. This amended language was incorporated into the Bylaws distributed in preparation for the February 25, 2022 board meeting.

Chair Fisher asked for a motion to adopt the resolution. Trustee McFoy so moved. Trustee Brown-Robinson seconded. Chair Fisher asked for a roll call vote and the motion passed unanimously.

RESOLVED that the modifications to the Amended Bylaws are approved as presented with the additional language from Trustee Fedrizzi.

Adjournment

With no further business, Chair Fisher called for a motion to adjourn. Trustee Brown-Robinson so moved and seconded by Trustee Fedrizzi. The meeting was adjourned at 11:30 am.
