# 1. Call to Order, Roll Call and Welcome

Chair Bartow called the meeting of the ESF Board of Trustees to order at 12:00 p.m. Secretary Lichtenstein took roll call and confirmed a quorum with five voting trustees in attendance in person and one voting trustee participating from a location shared with the public in advance.



- 2. Approval of Agenda Chair Bartow noted that agenda item #7, the Chief Information Officer Update would be removed from the agenda. Trustee Fedrizzi motioned to approve the updated agenda. Trustee Fitts seconded, all approved.
- 3. Consent Agenda Chair Bartow presented the consent agenda items as follows:
  - Approval of the Minutes of the May 9, 2025, Board Meeting.
  - Personnel Actions Presented for Board Review.
- D. Glance noted the misspelling of her name on page 3 of the minutes and requested an amendment to make the correction. Trustee Fedrizzi motioned to approve the minutes as ammended, Trustee Fitts seconded. All approved.

# 4. Chair's Report – Chair Bartow

- In Contact with President Mahoney often. Moving targets on stabilization plan. Has been challenging, Board would have liked better communication, but the stabilization plan has been accepted by SUNY. Next 90-100 days will be very busy. Situation remains fluid.
- ACT Meeting in October better understanding of SUNY system and
- All SUNYS and higher education are facing financial challenges, if anything positive from stabilization process, it's that we are in a good position to move forward.

# 5. Committee Reports

- **Governance:** did not meet but discussed composition, added D. Glance as a committee member.
- DEI: Co-chair Bartow reported on the committee meeting.
  - o Introduction of new CDO, Seth Thompson.
  - No mission or scope changes.
  - o Membership: Co-Chairs Bartow and Brown-Robinson, D. Glance, Trustee Vera.
  - CDO asked to work toward a DEI Strategic Plan and to work with the campus IDEA Committee.
- Facilities: Chair Fedrizzi reported on the committee meeting.
  - Discussed Charter.
  - M. Lichtenstein provided information on facilities and funding sources.
  - o Membership: Chair Fedrizzi, Trustee Fitts, E. Friden.
- Finance: Bartow as chair, V. DeMarchi, D. Vera.
  - President Mahoney reviewed the stabilization plan,
    - Focus on growth.
      - Summer and Online Programs
      - Add Winter Programs
    - Maintaining R2 status is a priority.
    - Voluntary Separation Program, need to cut 38 FTE,
      - hopeful that VSP will address most FTE reductions.
      - President Mahoney receives daily updates on applications to VSP



- > \$1M for incentive payments, current applications at \$900K representing 2.? M salary savings.
- Application deadline is October 24<sup>th,</sup> and decisions will be communicated to Board as soon as possible.
- President Mahoney shared that last week SUNY greenlighted \$1.8M for incremental funding to ESF.
- Budget goes into the black in year 3.
- SUNY has agreed to additional \$1M to ESF in years 4 and 5.
- President Mahoney noted that she appreciated the advocacy and that is has turned into real dollars.

## 6. President's Report:

Acknowledged presence of athletes at meeting, noted that they missed the update during the Finance Meeting that the cost of the athletics programs is \$500,000 and that there is a \$100,000 difference between revenue and expenses. Asking Department of Athletics to balance spending with revenue. Asking many other departments at ESF to do the same, including The Graduate School.

- o Summer Program Growth: 2021 enrollment 252, 2025: 369
  - ESF matriculated: 209 to 287.
- 246 students took courses at Cranberry Lake.
- o Timbuctoo Climate Science and Careers Summer Institute had another successful year.
- o ESF Summer Science Corps and Summer Science Week.
- ESF returned to the New York State Fair.
- National Institute for Student Success
  - Focus on academic supports such as tutoring and supplemental instruction on high enrollment, gateway courses with significant Drop Fail Withdraw (DFW) rates: will use these to drive additions to summer and winter courses.
  - Help students succeed, retain revenue if retention rates go up slightly.
    - #1 Focus is students.
- Goodnow Fire Tower has been rebuilt, thanked Paul Stacy and Private Donors.
- MSCHE visit report is confidential but will report out to board when results are final.

- Kevin Reynolds passed away on campus near Robin Hood Oak. Memorial Service on Thursday, October 2<sup>nd</sup> 11 AM − 12:20 PM in the Gateway Center.
- Enrollment: Thanked Admissions staff, student affairs orientation leaders, staff at centennial hall.
  - New Class 375 Undergraduate Students, 152 Transfer Students, 79 Graduate Students,
     60 Ranger Schools Students.
  - o Daily Enrollment Tracking 1853 Undergrad, total 2228. Enrollment is not an issue.
- Budget 2025-2026:
  - o Budget is different from stabilization plan.
  - Stabilization plan now feeds the annual budget.
  - Direct State Tax Support Base of \$19.6M up to \$25.9M, base remains the same, amount over \$19.6M is incremental funding.
  - o Tuition dipped from last year, likely tied to reduction in scholarship dollars.
    - \$21.3M in tuition revenue in 22-23, \$26.7M in 25-26
  - Increase in utilities and negotiated salary increases (well deserved).
  - Collect more revenue, spend less, reduce deficit.

President Mahoney noted that ESF is not immune to challenges in higher education, many others are planning staff reductions. Not looking at program closures, loss in enrollment has not occurred, but need to balance revenue and expenses.

# • Foundations of Stability Plan

- o Growth in summer, winter, online, and experiential learning opportunities.
- Growth in undergraduate enrollment.
- Growth in graduate school enrollment.
- Growth in research portfolio.
- Information feeding stabilization plan allows us to be strategic.
  - Stabilization plan has been approved, because we will be in the black.
  - o SU contract was not paid in 2024-2025, not a true jump in 2025-2026.
  - o FTE: 5.4 ratio in 2014/2015, what is planned in the stabilization plan is achievable.
  - Accumulated deficit of \$16.1M at end of stabilization plan,
    - Without any changes the accumulated debt would have hit \$59M in the end.
    - Not acceptable to SUNY System, can't operate with 64 campuses generating debt.

#### Plan Goal

- Ensure the continued, financially sustainable, operation of ESF as New York State's premier R2 Carnegie ranked, leader in Environmental teaching and research.
  - Graduate minimum of 20 PhDs/year to maintain R2 Carnegie rating.

#### Improvements:

- Assessment
- Annual Budget Process
- Stabilization Plan Development & Implementation
  - Involved 100's of meetings with SUNY. President Mahoney thanked everyone doing the work, Kitty, Ragan, Brenda, Lindi, Baylee, Matt.

Ended with a reminder of why ESF is here. Teach students, find new ways of thinking about



sustainability and climate, build workforce, make discoveries, we are here to improve our world.
